Sub:- Opening of a Commerce College in the premises of the College.

Ref:- His letter No. 658/66-67 dated 31/8/66.

The undersigned begs to observe that Siliguri Commerce College was started in 1962 in the premises of the Siliguri College, which has also been affiliated to the University of North Bengal without having prior approval of this Directorate.

In this connection, it may be noted that as a matter of policy, opening of Commerce classes in the evening outside the Sponsored scheme is not refused by this Directorate but the authorities of the Sponsored Colleges are required to abide by some prima facie conditions which are as follows :-

1. The classes should be held in the premises of the College outside the College hours in the evening.
2. Furniture and fixture of the College may be utilised on condition that repair and renewals consequent to their use by the Commerce Department are regularly attended to.
3. Proportionate cost of electric current consumed is met by the Commerce Department.
4. Sponsored College staff teaching and Non-teaching is employed on a ~~part~~ part-time basis with prior approval of this Directorate.
5. A separate Governing Body for the Commerce Unit is made in the course. The composition of the Governing Body of the Commerce Unit should be same as that of the College (Siliguri College) except the Principal-Secretary and the Teachers' representatives of the College. The Principal (Siliguri College) should be the Vice-President of the Commerce Unit.
6. All Non-recurring and recurring expenditure required for running the Commerce Department is met by the authorities of the Commerce Unit from local sources.
7. The Commerce Unit arranges a separate library for its students.
8. The Commerce Unit should have the same name (as Siliguri College of Commerce).
9. The Principal (of Siliguri College) should remain in charge of the Commerce College till a separate administrative block and a library building are built up for commerce college and a separate Principal for the Commerce College is appointed.

In the circumstances he is requested to place the matter before the Governing Body of the College for consideration and to let this office know if the authorities of the Siliguri College agree to abide by the above mentioned conditions.
