#### Answer all the questions

 X Transport Ltd. purchased from Y Motor 3 scooties costing Rs. 50,000 each on hire purchase basis on 01.01.2011. Payment are to be made Rs. 30,000 down and the remainder in 3 equal annual instalments payable on 31.12.11, 31.12.12 and 31.12.13 together with interest @ 9% p.a. X Transport Ltd. write off depreciation @ 20% on W.D.V. method. It paid the instalment due on 31.12.11 but could not pay the instalment due on 31.12.12. Y Motor agreed to leave one scooty with the purchaser on 01.01.2013 adjusting the value of other scooties against the amount due on 31.12.12. The scooties were valued on the basis of 30% depreciation annually.

Pass necessary journal entries in the books of X Transport Ltd. for all the three year.

2. X Ltd. of Siliguri has its branch at Birpara to which goods are sent @ 20% above cost. Branch expenses are met partly from the H.O. and partly by the branch.
